HOTEL TERMS AND CONDITIONS:

- Check-in at the hotel from 14.00 h
- Check-out from the hotel until 12.00 h
- Baby cot is free of charge and must be reserved in advance.
- Children up to 3 years old stay for free in the hotel.
- Children from 3 to 7 years of age in a shared bed accompanied by an adult, pay only for selected meals.
- Children from 7 to 12 years of age in a separate bed pay 70% of the price of the bed. The parent is obliged to show the child's passport.
- Use of parking is free for hotel guests

TERMS AND METHOD OF PAYMENT

- Prices are in RSD per person, for the selected room type with VAT included.
- Breakfast is included in the price.
- The price does not include the local tax, which is charged in the amount of 95.00 RSD per day per person and insurance of 15.00 RSD per day per person. Children up to 7 years of age pay insurance only, children from 7 to 15 years of age pay insurance and local tax reduced by 50%.
- Payment can be made in cash, by bank transfer as well as by cards: Visa, Dina, Master, Maestro. The hotel reserves the right to pre-authorize credit cards.
- If the payment is made by a company, it is necessary to pay an advance of 50% based on the proforma invoice at least 2 days before the arrival of the guest.
- If the payment is made by a tour operator for pre-arranged accommodation of a tourist or other group, it is necessary to pay an advance of 50% no later than 14 days before arrival at the Hotel.
- Payment from abroad can be made by payment to the Hotel's foreign currency account (bank charges are borne by the payer, otherwise the costs will be charged at the Hotel
- reception) or by credit card (the Hotel reserves the right to pre-authorize.)
- All additional guest costs, such as the cost of a minibar and other additional services, are charged upon check-out from the Hotel.

COMPENSATION FOR DAMAGES

- In case the confirmed reservation is canceled 3 days before arrival, the Hotel will not charge the client. In case of no-show, cancellation or any change of reservation within less than 3 days, the Hotel reserves the right to charge the amount of one bed and breakfast service from the Pricelist.
- In case of cancellation of a group reservations:
 - Cancellation of the announced and confirmed group by the service user must be submitted in writing.
 - A group means set of 10 or more persons who are staying in organized manner in the Hotel.
 - A confirmed group is one for which the travel organizer has agreed in writing or by paying in advance with the offered conditions and methods of payment which are an integral part of the Hotel's business.
 - The reservation will be canceled without cancellation costs, if the stay of the group is canceled at least 14 days before the agreed date of the service.
 - If the reservation for the group is canceled in a period shorter than 14 days and longer than 7 days before starting to use the services, the Hotel reserves the right to charge 40% of the value of the contracted work for damages,
 - If the reservation for the group is canceled in a period shorter than 7 days and longer than 48 hours before starting to use the services, the Hotel reserves the right to charge 50% of the value of the agreed amount.
 - If the reservation for the group is canceled 48 hours before the scheduled date, the Hotel reserves the right to charge for damages 80% of the value of the agreed amount.
